The Remote E-voting was open from Sunday, 15th September, 2024 from 10.00 a.m. (IST) to Tuesday, 17th September, 2024 upto 5.00 p.m. (IST).

The Board of Directors had appointed Mrs. Monalisa Datta Practicing Company Secretaries as the Scrutinizer for the remote e-voting and -voting during the AGM by Members. Mrs. Datta has carried out the scrutiny of all the remote electronic votes received up to 5.00 p.m. (IST) on 17th September, 2024 and E-votes cast through E-voting system during the AGM, received till the conclusion of the AGM and has submitted her report on 18th September, 2024.

Based on the consolidated Report of the Scrutinizer, all the resolutions as set out in the Notice of the AGM have been duly approved by the members with requisite majority.

SUMMARY OF PROCEEDINGS OF THE ANNUAL GENERAL MEETING OF THE COMPANY FOR THE FINANCIAL YEAR 2023-2024 HELD ON 18TH SEPTEMBER, 2024, PURSUANT TO REGULATION 30 OF THE SECURITIES AND EXCHANGE BOARD OF INDIA (LISTING OBLIGATIONS AND DISCLOSURE REQUIREMENTS) REGULATIONS, 2015

The Annual General Meeting ("AGM" or "Meeting") of the Members of Bhatkawa Tea Industries Limited ("the Company") for the financial year 2023-2024 was held on Wednesday, 18th September, 2024, at 12.00 p.m. (IST) through Video Conferencing ("VC")/Other Audio-Visual Means ("OAVM"), without physical presence of the Members at a common venue. The Company, while conducting the Meeting, adhered to the Circulars issued by the Ministry of Corporate Affairs ("MCA"), the Securities and Exchange Board of India ("SEBI").

In accordance with the Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India ("ICSI") read with Guidance/Clarification dated 15th April, 2020 issued by the ICSI, the proceedings of the AGM were deemed to be conducted at the Registered Office of the Company which was the deemed Venue of the AGM.

Mrs. Dharini Mehta, Company Secretary welcomed the members to the meeting and enquired on wellbeing of the members and their families. She acknowledged the presence of all the Directors of the Company, including Chairperson of the Audit Committee, Chairperson of the Nomination and Remuneration Committee and Chairperson of the Stakeholders Relationship Committee, who were attending the AGM through Video Conference. She informed the Members that the Chief Financial Officer of the Company, the Authorised Representatives of the Statutory Auditors and Secretarial Auditor of the Company were attending this Meeting through Video Conference.

On unanimous consent of the Board, Mr. Padmanabh Jalan chaired the proceedings of the meeting. Upon the requisite quorum being present, the Chairman called the meeting to order. He requested Mrs. Dharini Mehta, Company Secretary to take the proceedings further. Mrs. Mehta paid her respects and condolences with respect to demise of promoter member and President of the Company, Late Shri Sudarshan Jalan. She thereafter requested Mr. Padmanabh Jalan to brief the members with performance of the Company and future prospects.

Mr. Padmanabh Jalan, Whole-time Director welcomed the members joining over Video Conferencing. He then briefed the members on the performance of the Company and challenges faced by the company and Tea industry as a whole due to increase in input costs and manpower costs. He then requested Mrs. Mehta to take over the proceedings. She requested the members to update their contact details, bank and other details with the Company / RTA and also insisted the members to dematerialise their shares.

As per the attendance records, 19 Members attended the Meeting through VC/OAVM facility. Since this AGM was held pursuant to the MCA Circulars and SEBI Circulars through VC/OAVM, physical attendance of Members was dispensed with. Accordingly, the facility for appointment of Proxies by the Members was not available for the AGM.

The Notice of the meeting was read. The following items of business as laid down in the Notice of the AGM dated 12th August, 2024, were transacted at the Meeting:

ORDINARY BUSINESS:

1. Adoption of the Audited Financial Statements of the Company for the Financial Year ended 31st March, 2024 together with the Reports of the Board of Directors and Auditors thereon.



2. Re-appointment of Mr. Arjun Mitra (DIN-06967237), who retires by rotation and being eligible, offers himself for re-appointment.

Both the above resolutions, which were put to vote, were passed with requisite majority. Thereafter the Auditors Report was taken to be read since there were no qualifications.

The Company Secretary stated that the Company had provided the Members the facility to cast their vote electronically, on all resolutions set forth in the Notice. Members who attended the AGM through VC/OAVM facility and had not cast their votes through Remote E-Voting facility were provided an opportunity to cast their votes through the E-voting system during the Meeting. She then ordered activation of e-voting window for the Members attending the AGM and informed that the voting facility shall be available till 10 minutes after conclusion of the AGM.

One member had registered as Speaker to express views at the AGM and as such he was invited to speak thereon. He expressed his views on performance of the company, the profitability and non-declaration of dividend. The Company Secretary thereafter requested the Chairman to give his concluding statement.

The Chairman authorised the Company Secretary to receive the Scrutinizer's Register, Report on evoting and also to counter-sign the Scrutinizer's Report and declare the results of voting. He announced that the e-voting results along with the consolidated Scrutinizer's Report shall be informed to Stock Exchanges and also be placed on the website of the Company and Stock Exchanges.

The Chairman thanked the Members for their presence and support extended to the Company.

The Scrutinizer's Report on the combined voting results was received and accordingly, all the Ordinary Resolutions as set out in the Notice were declared as passed with requisite majority, as specified in Annexure B below.

The meeting ended with vote of thanks to the chair at 12.35 pm (including time for voting).
